Terms & Conditions

Competition: Tell us your tree story, Hobart


1. The Hobart City Council, 50 Macquarie Street, Hobart Tasmania 7000 ABN 39 055 343 428 is the Promoter ("the Promoter").
2. Entry into the competition is deemed acceptance of these conditions of entry.
3. Employees of the City of Hobart and their immediate families are ineligible to enter this competition.
4. Only residents of Hobart Local Government Area in Australia are eligible to enter this competition.
5. Delivery of the tree is restricted to an address within the Hobart Local Government Area, Australia.
6. The competition starts on **19 July 2022 at 4 pm (EST) and closes 31 July 2022 at 11 pm.**
7. The competition can only be entered by submitting an entry via the digital entry form on the City of Hobart website. To enter the competition, participants must write in 150 words or less about a particular tree in the municipality of Hobart that stole their heart. Drawings and photos can also be submitted as part of the entry.
8. Two staff members from the City of Hobart will judge the entries. One from the arboriculture and nursery, the second with expertise in story writing.
9. The winner will need to visit the City of Hobart nursery in Mornington during business hours to pick out their prize, a mature tree valued at more than \$200. Delivery of the tree within the municipality of Hobart is part of the prize.
10. The winner must have the permission of the land owner to plant the tree.
11. Entries will be deemed to be accepted at the time they are posted via the City of Hobart website entry form. No responsibility will be taken for lost, late or misdirected entries.
12. The winner's names will be published on the City of Hobart Facebook page and possibly other social media channels, as will a photo of the winner with their prize and/or the tree that forms the focus of their entry.
13. The winner will be contacted by phone and/or email within one day of the winner being decided. To enter the competition the winner will have needed to provide a valid email address and phone number as part of their entry. The promoter reserves the right to review the prize if the winner has not provided a valid email address or phone number.
14. In the event that for any reason whatsoever a winner does not take an element of the prize at the time stipulated by the Promoter then that element of the prize will be forfeited by the winner.
15. No responsibility will be held for loss or damage to goods. All prizes must be taken as offered and no exchange is available.
16. Prizes are not redeemable for cash and are not transferable to any other person.
