## City of Hobart - Christmas Decorations Competition Terms and Conditions

### For businesses and organisations

1. The competition is for Christmas decoration treatments that are visible at street level, from outside of the property, either during daylight or at night, either through windows or on external structures.
2. The competition is open to all businesses/organisations in the City of Hobart municipal area that have street visibility (accessible to the public), including not-for-profit charitable or community services, and shopping centres where individual businesses are eligible to enter, but excludes residential properties.
3. The Christmas Windows Decoration competition for businesses/organisations commences on **14 November 2018 at 09:00 am (EST)** and concludes on **20 December 2018 at 12 pm (EST)**.
4. Registrations open on 4 November and close 13 December 2018 at 5 pm.
5. To enter the competition, organisations must register online at [www.hobartcity.com.au/christmasdecorations](http://www.hobartcity.com.au/christmasdecorations) by 4pm on 13 December 2018.
6. Entrants must consent to having their premises photographed and these photos being displayed on the City of Hobart website [www.hobartcity.com.au/christmasdecorations](http://www.hobartcity.com.au/christmasdecorations).
7. Judging will take place from 14 to the 18 December 2018 and will either be conducted online from the photos taken of each display or in person.
8. The top three most creative displays will each win a \$1000 donation made by the City of Hobart to a registered charity of their choice and a Triple M advertising package of \$1000 to promote their business.
9. Upon entry it is a requirement that a registered charity is nominated and contact details for the charity are provided. The charity of choice is required to operate in Tasmania. The Council reserves the right to determine if the charity is registered.
10. Entrants that are a not-for-profit charitable or community services/facility are eligible to enter their own organisation for the nominated charity as long as the charity is a registered charity.

### People's Choice Awards

11. The People's Choice Award commences on **20 November 2018 at 09:00 (EST)** and concludes on **20 December 2018 at 12:00 (EST)**.
12. To enter the People's Choice draw, participants must complete their details using the official entry form at [www.hobartcity.com.au/christmasdecorations](http://www.hobartcity.com.au/christmasdecorations).

13. People's Choice Draw entries may also be submitted on the paper entry forms provided at the Elizabeth Mall Information Booth and City of Hobart Council Centre, by **20 December 2018 at 12:00 (EST)**.
14. The business/organisation whose display receives the most number of people's choice nominations will win a \$1000 donation made by the City of Hobart to the organisations nominated charity, and a Triple M advertising package of \$1000 to promote their organisation or business.
15. A member of the public will be randomly drawn from all People's Choice Award entries to receive a voucher valued at \$500 redeemable at the Tasmanian Travel and Information Centre. The prize is not transferable and not redeemable for cash.
16. The People's Choice draw is open to residents of Tasmania aged 18 years and over only.
17. Information on how to enter and the prize/s forms part of these conditions of entry. Entry into the competition is deemed acceptance of these conditions of entry.
18. Employees and their immediate families of the City of Hobart and suppliers associated with this promotion are ineligible.
19. Entries will be deemed to be accepted at the time of receipt. Incomplete, incorrect or incomprehensible entries will be deemed invalid. No responsibility will be taken for lost, late or misdirected entries.
20. Winners will be contacted by phone on the 21 December 2018 and the winners' names will be published on the City of Hobart website and announced on Triple M.
21. The prize winners will be notified by phone if able to be contacted by this means, or by email within seven (7) days of the draw.
22. The prizes must be taken as offered. Prize values are GST inclusive.
23. The prizes are not transferable to any other person/organisation.
24. The judge's decision is final and no correspondence will be entered into.
25. The competition winners must agree to have their photo taken and published via City of Hobart promotional channels.
26. The City of Hobart will take the necessary steps to ensure that any personal information provided by entrants in this competition remains confidential and is only used for the purposes of this competition. City of Hobart will not sell, trade or make available your personal information to others.
27. The Promoter's decision in relation to any aspects of the competition is final and binding on every person who enters and no correspondence will be entered into.
28. In the event that for any reason whatsoever a winner does not take an element of the prize at the time stipulated by the Promoter then that element of the prize will be forfeited by the winner.
29. The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with any prize/s except for any liability which cannot be excluded by law. The Promoter will not be responsible for any incorrect, inaccurate or incomplete information communicated in the course of or in connection

with this promotion if the deficiency is occasioned by any cause outside the reasonable control of the Promoter including without limitation technical malfunctions or failures.

The Promoter collects personal information about you to enable you to participate in this promotion but no further use of this information will be made. To facilitate your participation, the Promoter may disclose your personal information to other companies associated with this promotion. If you do not provide your personal information, the Promoter will not be able to enter you into this promotion.

If for any reason this promotion is not capable of running as planned, due to any causes beyond the control of the Promoter, which affect the administration security, fairness or integrity or proper conduct of this promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process.

In the case of the intervention of any outside agent or event which naturally changes the result or prevents or hinders its determination, including but not limited to vandalism, natural disasters, acts of God, civil unrest, strikes; the Promoter may in its absolute discretion cancel the event and recommence it from the start on the same conditions subject to State Regulation.
