Please note any requests made before 1 May will only be valid until June 30 of the same year. Requests made after 31 May will be valid for 24 months from 30 June the year of the request.

- Should the City deem that the control is not to a satisfactory standard as determined by it, under Section 2 (26) Code of Practice for Spraying in Public Places, the City may resume responsibility for the maintenance of the land, using herbicide products if deemed necessary.
- The City will undertake regular inspections of the property.
- Requests to be on the register are valid for 24 months from 30 June the year of application, after which time the request will expire. At this time it is the applicant's responsibility to renew their registration if they would like to remain on the no spray register.
