## When to use this form

Use this form if you would like to:

- register a food business e.g. a permanent cafe, restaurant or eatery that prepares and serves food and drinks (including coffee)
- register a mobile food business e.g. a food business that is able to move around such as a food van, food tent etc.
- give notification of a food business e.g. a business that does not prepare, serve or handle food, only sells food that is packaged by the manufacturer such as a petrol station or bottle shop selling potato chips, cheese, lollies, chocolate etc.

Once you have submitted this form an officer will contact you to arrange for payment to be taken. Please refer to the fees and charges for current registration fees.

For a once-off temporary food registration (an ongoing business) such as a stall at a local festival or market, you will be directed to another site to complete that application.

A new National Food Safety Standard has been introduced and will apply as of the 8 December 2023. This means you may be required to nominate an accredited Food Safety Supervisor on this application (providing their full name and date of birth). Further information about this can be found on our <u>website</u>.

If you are operating the food business in the name of a trust you will need to provide the details (full name and date of birth) of the nominated trustee.


