

## When to use this form

Use this form if you would like to busk or participate in speakers corner in the City. Speakers corner is only allowed in Elizabeth Mall at specified times and days. Busking is allowed in the Elizabeth Mall, Wellington Court or Franklin Square.

You can also busk at Salamanca on market days. To apply for a permit for this you will need to visit the Information Booth located on Salamanca lawns and a permit will be issued by the market supervisor.

If you would like to busk in an area than those listed please contact the City on 6238 2711 to check if this may be permitted.

Please note if you are under 16 years of age a parent or guardian is required to sign on your behalf.
